## Youth Camp Project

The Youth Camp Project at First Presbyterian Church was established by a generous donor to provide the children and youth of area churches with the opportunity to attend a Christian camp.

### **Applicant criteria:**

1. The student must be regularly participating in classes/activities at one of the participating churches.
2. The student must be in grades K through 12.
3. Applications will be accepted annually January 1 – May 15.
4. Awards are available for 1 camp experience per student, per year.
5. Typical annual award is a maximum of \$500. Registration fee to be paid by the camper.

### **Funding & payments:**

1. The student must register for the camp and pay the registration fee.
2. Complete the application and drop off or mail **both the application and proof of registration** to:

3. The Youth Camp Project accounting will be done through First Presbyterian Church, Grand Haven. The money is held in a church account. The account is handled the same way as all other designated funds of the church.
4. Payments will be made directly to the camps. Payments to reimburse parents are not allowed.
5. Money will be available as donor funding permits.

### **Donor Special Request:**

The donor would like all students to do work around the house or community to earn the money to cover the registration fee. Please consider asking your child to do serve in some way as part of receiving this gift.

**Camp Options:** Awards are available for Day Camp or Overnight Camp at any Christian camp. Please note, conferences and Vacation Bible School programs do not meet the parameters of the Camp Grant Program.
